

2008 EXHIBITORS CONTRACT

IF YOU WISH TO SET UP AS AN EXHIBITOR AT THE FFCA 2008 *COLLECTORS ROUNDTABLE AND/OR SHOW & SELL*, THIS CONTRACT MUST BE COMPLETED, SIGNED, AND RETURNED NO LATER THAN FRIDAY, SEPTEMBER 19, 2008, IN ORDER TO BE APPROVED.

FFCA AGREES TO:

- A. Provide a suitable location, and publicity to promote its *Collectors Roundtable* and/or *Show & Sell* event to FFCA members.
- B. Provide reasonable security.
- C. Provide table(s), 2 chairs, tablecloth and table sign for each exhibit.

EXHIBITOR AGREES TO:

- D. **LIMIT** unrelated Frankoma items to **NO MORE** than **25%** of the exhibit. *If you have a question, please contact Show & Sell Chairman.*
- E. **ACCEPT** the **table locations** as assigned.
- F. **BE** in attendance during *Collectors Roundtable* hours (7:30 p.m.–9:00 p.m) and/or *Show & Sell* hours (8:00 a.m.—3:00 p.m) and **NOT** dismantle booth before closing.
- G. **MARK** all items for sale with a **clear** and **legible** price; items *not* for sale must be marked likewise.
- H. **MARK** all **re-issues** and **reproductions** as such with a clear and legible label stating date of re-issue or reproduction.
- I. **MARK** damaged and/or restored pottery as such with a clear and legible label.
- J. **OBSERVE** the FFCA code of ethics (as stated in *Principles and Procedures for Membership*) as the prevailing rules of conduct.
- K. **BE** responsible for **collection** and **payment** of appropriate Oklahoma state and local sales taxes (9.5%).
- L. **ABIDE** by all local, city, and state laws.
- M. **EXPRESSLY** release and not hold liable FFCA **Reunion 2008** for damage, injury, or loss of any kind—due to any cause whatsoever—to the exhibitors' goods, property, person, family, or employees.

AUTHORIZED EXHIBITORS:

- N. All Exhibitors **MUST** be FFCA Members in good standing and **PREREGISTERED** (Official Registration Form) for Reunion 2008.
- O. All Exhibitors **MUST** be pre-registered on the form provided below, and **RECEIVED** by FFCA on or **BEFORE September 19th**.
- P. Only **TWO** authorized Exhibitors (*those listed below*) will be furnished *Collectors Roundtable* and/or *Show & Sell* ID badges, and only those **TWO** exhibitors will be **ALLOWED** into the setup areas on **Thursday from 7:00 p.m. to 7:30 p.m.** and/or **Saturday from 7:00 a.m. to 8:00 a.m.**
- Q. Exhibitors **MAY NOT** be added to your table or changed after this contract is approved by FFCA.
- R. Only **AUTHORIZED** Exhibitors will be furnished **2008 Collectors Roundtable** and/or *Show & Sell* ID badges.
- S. Exhibitors **MAY NOT** begin **SALES** until the *Show & Sell 2008* is officially opened at **8:00 a.m. Saturday, September 27th, 2008**.
- T. In case of any **DISPUTE**, the *Show & Sell 2008* Chairman's decision shall be final and binding.
